1. The **Province Hospital, Birendranagar, Surkhet** has allocated Fund from Hospital Development Committee in Province Hospital, Surkhet towards the cost of **The Procurement of Partition works** to apply part of the funds to cover eligible payments under the Contract for **PH/KARNALI/Works/NCB/02-2083/84**. Bidding is open to all eligible Bidders as defined in ITB Clause 4 (Eligible Bidders)
2. The Province Hospital, Birendranagar, Surkhet invites electronic bids from eligible bidders for the procurement of Laboratory Reagents, Kits, Chemicals & accessories under National competitive bidding – Single Stage Single Envelope procedures.
3. The bidder may submit the bid for single or more packages/lots as mentioned below and offer discounts/ cross discounts. Evaluation will be done for each package/lot, with contracts awarded based on the **award combination that is of Substantially responsive bid closest to the average bid price to the Purchaser.**
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Province Hospital,, Birendranagar, Surkhet**, 083523200, **provincehospitalskt@gmail.com**. or may visit PPMO egp system www.bolpatra.gov.np/egp.
5. **Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system (www.bolpatra.gov.np/egp) at no cost.**
6. **Pre-bid meeting shall not be held.**
7. electronic bids must be submitted to the office **Province Hospital, Surkhet** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **2026.09.02**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00PM, on **2026.09.02** at the office of **Birendranagar, Surkhet**. Bids must be valid for a period of **90 Days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NPR 106,000.00** which shall be valid for 30 days beyond the validity period of the bid **(i.e. 2026.12.09)**
9. If the last date of purchasing and /or submission falls on a public holiday¹ applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
